November 20, 2012

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, November 20th, 2012 with Tom Broeker, Dan Cahill and Bob Beck present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Engineer Brian Carter reported that crews were getting ready for winter by putting wings on the snow plows. Gina Erickson, IT Director, reported that county employees completed website training last week. She plans to go live with the new County website the first part of January. Jail Administrator Duane Worthy reported on the cases of two prisoners with mental health issues that show how mental health reform is affecting the Dept. of Corrections. Worthy stated that the legislation needs to be changed.

Under correspondence, a letter was received from American Ordnance notifying the Board of a permit modification.

Accounts Payable Claims in the amount of \$372,330.25 were approved upon motion by Cahill. Beck seconded.

A Class C Liquor License for the Yarmouth Café was approved upon motion by Cahill and second by Beck. The County Attorney and Director of Local Health had no objections.

Cahill moved to approve the Gas and Electric Utility Valuation Reconciliation Report for 2012. Seconded by Beck.

The Utility Assessment for 2012 was approved upon motion by Cahill and second by Beck.

Bob Housewright resigned after serving 25 years as Secretary of the Board of Health. Beck moved to accept with regret. Seconded by Cahill.

Broeker read letters of interest from Edward Phil Hubbard and LaVon Worley for a seat on the County Conservation Board. Following discussion of two outstanding candidates, Beck moved to approve LaVon Worley for the position. Seconded by Cahill, who suggested keeping Hubbard's letter for the next opening.

Ronald E. Breuer, 6097 108th Ave, has agreed to serve on the Des Moines County Zoning Commission. His term will run until January 2017. Motion to approve was made by Cahill and seconded by Beck.

The following personnel actions were submitted: at the Sheriff's Office, Erica Thomson took three days leave without pay. Motion by Beck. Second by Cahill. Christopher McElderry, IT Support Staff, received a salary adjustment following his six months probation. His new salary will be \$48,000 per year effective November 17th. Motion by Beck. Second by Cahill. In the Auditor's office, Karla B. Cornick was hired as Clerk II. Motion to approve was made by Cahill and seconded by Beck.

The following reports were received and filed: Case Management report for October 2012 General Assistance report for October 2012 Boarding and Lodging Report, October 2012

Cahill moved to approve minutes for the Board meeting held on November 13th, 2012. Seconded by Beck.

During committee reports, Beck had attended a Chamber of Commerce meeting and the hearing on the Orascom fertilizer plant in Lee County. Beck stated that the Supervisors need to work with Burlington and West Burlington to decide the best route through or around Burlington. Broeker and Beck had also attended a meeting about mental health regionalization in Mt. Pleasant.

Meeting was adjourned at 9:36 AM.

A work session was held with members of the County Conservation Board. This meeting was closed per Code Section 21.5 1. (c).
