The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, May 20th, 2014, with Bob Beck, Jim Cary and Tom Broeker present.

Unless otherwise noted, all motions carried.

Meet with Department Heads: County Engineer Brian Carter stated that the weather is getting close to optimum conditions to apply dust control. Chris Lee, Director of County Conservation, reported that his department is gearing up for Memorial Day weekend. A sidewalk to the cabin is being poured today. Reservations for camping sites are filling up. CPC Ken Hyndman reported on the SEIL board meeting last week. He asked the board to set a work session with Hope Haven to discuss a new contract for the care facility. He is working on a contract for the crisis center. Chief Deputy Jeff White stated that there will be a meeting of the DESCOM Board on Wednesday, May 28th, and asked that the Board make their appointments to that Board next Tuesday. Broeker added that the COBCO Board has decided that DESCOM is a separate entity and employees will have to have their own insurance plan after their employment contract expires.

Matthew Bessine, local attorney and President of the Des Moines County Law Library Association, spoke to the Board about support for the law library in the court house. Bessine stated that the Association was organized in Jan. 1940 for the purpose of establishing the library to benefit judges and the public. They were made the beneficiaries of the James Smyth Trust in Sept. 1942, which contributes an average of \$750 per year towards the purchase of law books. They also receive about \$1,000 annually in court fees and the County has provided the balance needed. Bessine said that the Association is planning to dissolve and wants to transfer their assets to the County. They are asking that the County provide an Iowa Code Annotated each year. There will be a resolution on the agenda next week making this agreement official.

Accounts Payable Claims in the amount of \$1,126,403.88 were approved upon motion by Broeker and second by Cary. Broeker stated that about \$750,000 was for payment of the Landfill G.O. bonds. The landfill has deposited that amount with the county.

Jeff Hanan, Land Use Administrator, presented a Resolution and Final Plat for Bill Huber/ Enke Subdivision. Hanan stated that this is a minor one lot sub and recommended approval. The Board, with the knowledge that this lot will be used for a pork confinement, questioned an adjacent house that is shown on the plat. Hanan stated that the house is abandoned at present but as the county has no zoning regulations there is nothing to prevent the subdivision. It is required by Code to be separated from the larger tract before conveying title. Motion to approve was made by Cary and seconded by Broeker.

RESOLUTION

WHEREAS Section 354.8 of the Code of Iowa states that a governing body shall certify by resolution the approval of a subdivision plat, and,

WHEREAS the Final Plat for **Bill Huber/Enke Subdivision** has been reviewed for conformance to applicable County standards by the Des Moines County Health Department, Secondary Roads Department, County Auditor, Zoning Commission Chair and Land Use Department and has been duly recommended by the aforementioned entities for approval,

NOW THEREFORE, BE IT RESOLVED: That the Board of Supervisors hereby approves the Final Plat of **Bill Huber/Enke Subdivision.**

Zach James, Regional Planning, presented a Federal Aid agreement between Iowa DOT and the County for the construction of Flint River Trail Phase 1A. James explained that a recreational trail grant in the amount of \$413,000 and \$211,000 in transportation funds has been received. Motion to approve this agreement was made by Broeker and seconded by Cary.

James also presented a contract renewal between SEIRPC and Des Moines County for continued development of the Flint River Trail. This contract takes effect July 1, 2014. It is a three year contract at \$12,500 per

year. Broeker moved to approve. Seconded by Cary.

Cary moved to approve a one day Outdoor License for Yarmouth Café. Sheriff Johnstone had no concerns about this event. Seconded by Broeker. The effective date is May 24, 2014.

The following personnel actions were approved: in the Auditor's office, Clerk II Karla Cornick received her 18 month anniversary increase. Motion to approve was made by Broeker and seconded by Cary. At the Conservation department, three summer interns were hired effective May 19 through August; Dilan Beaird, Robyn Smalley and Will Rechkemmer. Motion to approve was made by Cary and seconded by Broeker.

The following reports were received and filed: Sheriff's Monthly Report, April 2014 Clerks Report of Fees Collected, April 2014

Broeker moved to approve minutes for the Board meeting held on May 13th, 2014. Seconded by Cary. Future Agenda Items: resolution to support law library and appointments to DESCOM Commission. Committee reports: Broeker attended meetings for Grow Greater Burlington, Board of Health, REAP, a meeting regarding security cameras and a City/County Health Board (COBCO) meeting. Broeker reported that insurance premiums were going down slightly and pointed out that the local Two Rivers did not have a problem with overbilling. That problem was discovered at another office in the state. Beck attended a SEIL Board meeting and Small Business Appreciation breakfast.

Meeting was adjourned at 9:56 AM.
