

July 15, 2014

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, July 15<sup>th</sup>, 2014, with Bob Beck, Jim Cary and Tom Broeker present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Engineer Brian Carter credited staff for compiling flood damage information for FEMA projects. He reported that a retaining wall fell over in a flooded area. Conservation Director Chris Lee suggested several solutions to slow movement of rain water to creeks and rivers. He stated that dredging the river is not the only answer to epic flooding. Preventing topsoil and water from reaching the river is the key. Lee also reported receiving a \$20,000 grant from Pheasants Forever that will be used for land acquisition. Emergency Management Director Gina Hardin took part in the flood assessment in the City of Burlington. There are eleven businesses that need assistance to repair damage. The Small Business Administration sets the limit at 25, so Burlington might not receive any funding. Community Services Director Ken Hyndman reported that his office was struck by lightning so computers and other electronic devices are not working.

Accounts Payable Claims in the amount of \$482,372.07 were approved upon motion made by Cary. Seconded by Broeker.

Broeker moved to set July 22<sup>nd</sup> as the date for a public hearing to make Brush College Road a Class C road. Seconded by Cary. This was changed from July 15<sup>th</sup> due to the newspaper not publishing the legal notice on time.

Travis Kraus with SEIPRC submitted a contract for services with Des Moines County. This contract is for updating the Des Moines County Multi-Jurisdictional Hazard Mitigation Plan. Kraus stated that a local match is required, which can be volunteer hours. Motion to approve was made by Broeker and seconded by Cary.

The Quarterly report for the Byar Trust was received and filed. Broeker noted that this trust allows rural taxpayers 3.5 cents reduction in their levy rate.

Broeker moved to approve the Cash on Hand letter from the County Treasurer's office as of June 30, 2014. Cary seconded.

Future agenda items: public hearing for Brush College Road. Board is waiting for more input on the fireworks ordinance.

During committee reports, Cary had attended a RUSS meeting. Broeker had attended a DesCom meeting, where he learned that an applicant has been offered the job as Director, and a Case Management meeting.

Meeting was adjourned at 9:51 AM.
