The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, December 16th, 2014, with Bob Beck, Jim Cary and Tom Broeker present.

Unless otherwise noted, all motions carried.

Meet with Department Heads: County Engineer Brian Carter reported that work on 140th St. is complete except for touch-ups in the spring. He was notified by IAAP that they will be closing Gate 4 and moving all traffic to Gate 3 on a trial basis. He will be watching that area to determine if some turn lanes have to be built on Old Highway 34. This change takes place on Wednesday. Conservation Director Chris Lee reported that he is planning a renovation project on the Nature Center. He hopes to have offices moved from second floor to first floor before April. This will be a five year project to improve the building and displays and will be paid for by a grant from the Murray Trust. City/County Safety Director Angie Vaughan reported that she has one more CPR class to give for employees.

Accounts Payable Claims in the amount of \$286,439.21 were approved upon motion by Cary and second by Broeker.

Beck administered the oath of office to Assistant County Attorney Andrew L. Mahoney. Mahoney began work on December 8th, 2014.

Des Moines County Treasurer Brenda Stellern requested the Board cancel delinquent taxes on numerous mobile homes. She stated that these mobile homes do not exist anymore and she has exhausted all attempts to contact the owners to pay the back taxes. This action was approved upon motion by Broeker and seconded by Cary.

Upon recommendation by Judge Linn, the appointments of Russell D. Fry, Tamarra Washington and Nancy Schulte to the Magistrate Appointment Commission were approved for another six year term. Motion to approve was made by Broeker and seconded by Cary.

Donald W. Mathews was appointed Clerk of Pleasant Grove Township upon motion by Cary and second by Broeker. This is a four year term.

Motion to approve a 2% increase for calendar year 2015 for Sallie Benedict, Patient Advocate, was made by Broeker and seconded by Cary. Community Services Director Ken Hyndman explained that Benedict is overseen by District Court Judge Brown and this is Brown's recommendation. Benedict's salary is paid by Lee, Louisa, Henry and Des Moines Counties.

Committee reports: Broeker attended meetings of SE IA Link Board, Grow Greater Burlington and the Fifth District County Officers meeting. Cary attended meetings for RUSS and Department of Corrections, Eighth Judicial District. Beck also attended the Fifth District meeting.

Public Input Session #2, Larry Williams, 1567 Mason Lane, reported on the City's plan to build a flood wall along the riverfront to prevent future catastrophic flooding. This will be funded with a State mitigation grant.

Meeting was adjourned at 9:55 AM.
