## March 15, 2016

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, March 15<sup>th</sup>, 2016, with Tom Broeker, Bob Beck and Jim Cary present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Engineer Brian Carter reported that rain is slowing work but crews did complete one culvert on Irish Ridge Road. They are ditching gravel roads when they can. Pleasant Grove Road will be closed between Highway 61 and Iowa City Road for five to six weeks. A box culvert will be replaced and the road repaved. Conservation Director Chris Lee reported that work sessions with his Board will be held on March 28<sup>th</sup>, April 4<sup>th</sup> and 5<sup>th</sup> and invited the Supervisors to attend. Lee will be showing them various conservation projects. Lee also reported that burn season has begun for parks so the public will be seeing smoke from those areas. DCS Ken Hyndman stated that Case Managers are busy with Medicare webinars. He will be attending several region meetings tomorrow.

The following correspondence was received and filed: a letter from Iowa Workforce Development regarding available training on heavy construction equipment. The training is being offered to low income women but the opportunity is also extended to the general public. A Walmart Foundation Grant is making this training possible.

During public input session #1, Chris Lee had come from a Greater Burlington Partnership meeting and reported that Burlington is the winner of the Big Muddy Cup which means there is more private investment per capita than any other community along the entire Mississippi River Corridor. Burlington has also been designated the number one micropolitan in Iowa, which makes it thirteen in the nation. He also listed several new businesses and other improvements happening through public and private efforts.

Accounts Payable Claims in the amount of \$228,334.81 were approved upon motion by Cary and second by Beck.

Beck moved to open a public hearing for the purpose of approving a General Obligation Loan agreement. The County will be borrowing \$2,650,000 to pay for County health insurance, worker's compensation, and liability insurance programs. Cary seconded. There was no public comment. Motion to close the public hearing was made by Beck and seconded by Cary.

Beck moved to open a public hearing for the purpose of approving a General Obligation Loan agreement. The County will be borrowing \$222,177 to pay for the cost of making repairs and improvements to County buildings and acquiring equipment for County buildings. Seconded by Cary. There was no public comment. Motion to close the public hearing was made by Beck and seconded by Cary.

Beck moved to open a public hearing for the purpose of approving a General Obligation Loan agreement. The County will be borrowing \$126,000 to purchase vehicles for the County Sheriff and Public Health departments. Cary seconded. There was no public comment. Motion to close the public hearing was made by Beck and seconded by Cary.

Broeker read the Resolution providing for the Debt Service Property Tax Levy in the total amount of \$2,666,900 for the fiscal year beginning July 1, 2016. Beck made the motion to accept this action. Cary seconded. Roll-call vote: Beck, Aye Cary, Aye Broeker, Aye

#### RESOLUTION

Resolution expressing intent to authorize a Loan Agreement and issue Bonds in an amount not to exceed \$3,000,000 and providing for the levy of taxes to pay the same

WHEREAS, Sections 331.402, 331.441 and 331.442 of the Code of Iowa authorize counties to enter into loan agreements and borrow money for the purpose of paying the cost of various County insurance programs,

making repairs and improvements to County buildings, acquiring equipment for County buildings and acquiring vehicles for County departments; and

WHEREAS, the Board of Supervisors (the "Board") of Des Moines County, Iowa (the "County"), has proposed to enter into a loan agreement (the "Insurance Loan Agreement") in a principal amount not to exceed \$2,650,000, pursuant to the provisions of Sections 331.402 and 331.441 of the Code of Iowa, for the purpose of paying the costs, to that extent, of County health, workers compensation and liability insurance programs, and has published a notice and held a hearing on that proposal; and

WHEREAS, the Board also has proposed to enter into a loan agreement (the "County Building Improvements Loan Agreement") in a principal amount not to exceed \$222,177, pursuant to the provisions of Sections 331.402 and 331.441 of the Code of Iowa, for the purpose of making repairs and improvements to County buildings and acquiring equipment for County buildings, and has published a notice and held a hearing on that proposal; and

WHEREAS, the Board also has proposed to enter into a loan agreement (the "County Vehicles Loan Agreement") in a principal amount not to exceed \$126,000, pursuant to the provisions of Sections 331.402 and 331.442 of the Code of Iowa, for the purpose of acquiring vehicles for the county sheriff and health department, and has published a notice and held a hearing on that proposal and no petition has been filed requesting that an election be held on that proposal; and

WHEREAS, it is necessary at this time for the Board to express its intent to authorize the three loan agreements for the purposes set out above and to express its intent to issue General Obligation County Purpose Bonds in a principal amount not to exceed \$3,000,000 (the "Bonds") to be issued in the future in evidence of the obligation of the County under those loan agreements;

NOW, THEREFORE, Be It Resolved by the Board of Supervisors of Des Moines County, Iowa, as follows:

Section 1. The County hereby determines to enter into a General Obligation County Purposes Loan Agreement in the future, providing for a loan to the County in a principal amount not to exceed \$3,000,000 for the purposes set forth in the preamble hereof.

Section 2. The County also determines to issue the Bonds at the time such funds are needed.

Section 3. For the purpose of providing for the levy and collection of a direct annual tax sufficient to pay the principal of and interest on the Bonds, there is hereby ordered levied on all the taxable property in the County a direct annual tax for collection in the fiscal year beginning July 1, 2016, sufficient to produce the amount of \$2,666,900.

Section 4. A certified copy of this resolution shall be filed with the County Auditor, and the County Auditor is hereby instructed to enter for collection and assess the tax hereby authorized. When entering such taxes for collection, the County Auditor shall include the same as a part of the tax levy for Debt Service Fund purposes of the County and when collected, the proceeds of the taxes shall be converted into the Debt Service Fund of the County and set aside therein as a special account to be used solely and only for the payment of the principal of and interest on the Bonds and for no other purpose whatsoever.

Section 5. All resolutions or parts thereof in conflict herewith are hereby repealed to the extent of such conflict.
