# September 27<sup>th</sup>, 2016

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, September 27<sup>th</sup>, 2016, with Tom Broeker, Bob Beck and Jim Cary present.

Unless otherwise noted, all motions passed unanimously.

Changes to tentative agenda: item 6F will be tabled until next week.

Meet with Department Heads: the County Auditor reported that her office has received over 2,400 absentee ballot requests. Emergency Management Director Gina Hardin reported that the Mississippi River is predicted to crest at 19.5 feet on Sunday. The flooding is the result of heavy rains in northern Iowa and Minnesota last week. Christa Poggemiller, Director of Public Health, announced that her department will be holding flu clinics for City, County and Waterworks employees beginning next week. County Engineer Brian Carter reported that the contractor is patching Bridgeport Road now. Also, work is continuing on Flint Bottom Road. That project will take several more weeks. County Attorney Amy Beavers thanked the Sheriff's office and Courthouse security guards for the extra security during the trial last week. County Treasurer Janelle Nalley-Londquist stated that her office is busy collecting property taxes. She reminded that the last day to pay the first half taxes without a penalty is Friday, September 30<sup>th</sup>. CDS Ken Hyndman reported that two case managers have been hired and he will be attending a Case Manager Advisory Board meeting tomorrow. City/County Safety Director Angie Vaughan reported that October is Fire Prevention month. There will be a fire drill on October 26<sup>th</sup> and employees will be trained on using a fire extinguisher.

Jeff Hanan presented the Resolution and Final Plat for Scenic Valley Subdivision. Hanan stated that this is a three lot subdivision owned by Kermit Ted Nelson and located in Huron Township. The Zoning Board approved this subdivision unanimously. Hanan recommended approval. Cary moved to approve. Seconded by Beck.

Sandy Dockendorff, Chair of the County Democrat Party, spoke in favor of raising the minimum wage in Des Moines County. She stated that 3 out of 5 small business owners support raising the minimum wage and added that Walmart increased their hourly rate nation-wide from \$9 to \$11. Dockendorff pointed out that Des Moines County is the 16<sup>th</sup> most populous county but ranks 81<sup>st</sup> in median household income. Angie Vaughan, speaking as a private citizen, stated that raising the minimum wage would be devastating to her laundromat business. She tries to be fair to her employees but can't afford to pay much more per hour. She prefers to give bonuses when possible. Peggy Wunderlich stated that several years ago she was a single mom, working two minimum wage jobs and raising two children on her own. She said that the Supervisors should want to help get workers off welfare. Broeker responded with statistics from the Congressional Budget Office. That report shows that a wage increase would lift 900,000 people above the poverty line but would also result in a net loss of up to 500,000 jobs. Broeker concluded that unemployment would be a worse result than a low paying job. Beck stated that he thought raising the minimum wage is the State's duty. If Des Moines County wants to attract big business but has a higher minimum wage than neighboring counties, the business will probably locate there. Dockendorff asked the Board to check the information on the links she provided. She plans to return to discuss this issue again.

The following personnel actions were approved: at Community Services, Carla Mertens was hired as Case Manager effective September 26, 2016. Her salary will be \$37,513.68 annually. Catherine Jarrett, Case Manager Supervisor, completed her orientation. Her salary remains the same at \$45,100.00. Motion to approve both actions was made by Cary. Beck seconded.

Beck moved to approve minutes for the Board meeting held on September 20<sup>th</sup>, 2016. Seconded by Cary.

Future agenda items: approval of a lease between Harmony Bible Church and DHS. Also, a work session with the County Attorney and Sheriff regarding a County Ordinance dealing with dogs running loose in rural areas.

Committee reports: Cary attended a Community Action Board meeting. Beck attended meetings of the Solid Waste Commission and DeCat.

Meeting was adjourned at 10:09 AM.
