November 15th, 2016

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, November 15th, 2016, with Tom Broeker, Bob Beck and Jim Cary present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: Deputy Auditor Terri Johnson reported that ballots for the Danville School Special Election are available. County Engineer Brian Carter reported that crews are getting ready for winter by putting wings on motor graders. Conservation Director Chris Lee has been working with Maintenance Director Rodney Bliesener to sell excess items on govdeals.com. Director of Public Health Christa Poggemiller announced that the Board of Health will be having a meeting on Thursday this week. County Attorney Amy Beavers stated that jurors are being selected for a trial this week. CDS Ken Hyndman reported that he will be attending several meetings this week. Carter added that there is a Tri State Transportation meeting in Mt. Pleasant on Friday. He will be attending and offered to register the Supervisors.

The following correspondence was received and filed: a letter from American Ordnance requesting a permit modification.

Accounts Payable Claims in the amount of \$326,165.38 were approved for payment upon motion by Cary and second by Beck.

Chris Lee again spoke to the Board about borrowing \$250,000 from the County for capital improvements at Big Hollow. The loan will be repaid over a period of five years. Broeker offered to make it interest free, saving Conservation about \$15,000. All members are in favor. Broeker stated that since this is an interoffice loan, there is no need for bonding or public hearing. He asked the County Attorney to write a Resolution stating the terms of the loan and the Board will formally approve the Resolution in several weeks.

County Conservation Board member James L. Garnjobst submitted a letter asking to be reappointed to another four year term on that board. Beck moved to approve. Seconded by Cary.

The following township officers were reappointed to four year terms: Marvin Thomson, Tama Township Trustee LaVerne R. Neal, Tama Township Trustee Robert Wollam, Union Township Trustee Daniel W. Hull, Union Township Trustee Dan Wirt, Yellow Spring Township Trustee

The following personnel actions were approved: At the Correctional Center, Hillary May, part time CO, received an 18 month increase. Cary moved to approve. Seconded by Beck. At the County Attorney's office, Christopher Scarborough, Assistant County Attorney, received his 18 month salary increase effective November 26, 2016. His salary will be \$48,232.00 annually. Tammy Anderson, Collections Clerk/Back-up Receptionist, has completed her six month probation and received a salary increase to \$25,375. Jayme Rowley, Receptionist, is still on probation and has no benefits, took 5 days of unpaid leave. Motion to approve all three actions was made by Beck. Cary seconded. At Local Health, Judith Weatherwax, CNA, was suspended without pay for five days. Beck moved to approve. Seconded by Cary.

The following reports were received and filed: Sheriff's Corrected Report of Fees Collected, October 2016 Clerk's Report of Fees Collected, October 2016 General Assistance Monthly Report, October 2016

Cary moved to approve minutes for the Board meeting held on November 8th, 2016. Seconded by Broeker. Roll Call Vote: Cary, Aye Broeker, Aye Beck, Abstain

The results of the General Election were canvassed. Elections Coordinator Terri Johnson announced that 94 ballots were received after the Election but in time to be included in the final count. These ballots did not affect the outcome of the Election. Beck moved to accept the results as canvassed. Seconded by Cary.

During other business, Beck asked Christa Poggemiller if she had advertised for positions on the Board of Health. That Board will increase by two members.

Future agenda items: Conservation will have several personnel actions.

Committee reports: Cary attended a RUSS meeting. He reported that Bruce Hudson, Director of RUSS, is considering taking over a couple of rural water and sewer districts. The County's dues to RUSS would decrease with additional projects. Broeker attended a SEIL Board of Governor's meeting. They are considering establishing a crisis intervention team. He participated in a MHDS phone meeting. Broeker also stated that the county is advertising for Medical Examiner Investigators.

Meeting was adjourned at 9:47 AM.

Following the meeting, the Supervisors and County Engineer took a tour of road projects.
