

November 9th, 2021

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, November 9th, 2021 with Vice-Chair Jim Cary and Member Shane McCampbell present. Chairman Tom Broeker was absent. This meeting was also held electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meet with Department Heads: County Auditor Terri Johnson reported the City/School Election Canvass is on the agenda today and the Post-Election Audit will be held Wednesday, November 10th at 9:30 am. The Secretary of State has chosen Pct PW 1st ballot rotation to be audited. This will be the Danville School District board member race. IT Director Colin Gerst stated his office is busy. Sheriff Kevin Glendening stated everything is going well in his office. The jail population is 71. Promotional interviews will be held Wednesday for eight officers. Maintenance Supervisor Rodney Bliesener was present and had nothing new to report. Conservation Director Chris Lee stated his department is into the fall burn season. He stated the office will be closed at times when staff is pulled out to assist with the burns. They will be conducting burns through mid to late fall. Asst. Land Use Administrator Jarred Lassiter was present and stated they are busy. County Treasurer Janelle Nalley-Londquist reported her office is busy. County Engineer Brian Carter reported the big construction projects have slowed down. Still working on grading, ditching and blading projects. The dirt work on Pleasant Grove Road should be done this week. The intersections of Pleasant Grove Road and Dodgeville Road at Hwy 61 are still closed due to installation of temporary pavement for the winter. The Upper Flint Bottom Road and Hwy 61 intersection should be poured this week or next. County Recorder Natalie Steffener stated the OHV and Snowmobile registrations, and user permits expire December 31st. CDS Director Ken Hyndman stated the SEIL Region monthly meetings will be held this week. Safety Director Angela Vaughan was present. Assistant County Attorney Trent Henkelvig reported everything is good at the office and a couple of employees are in Des Moines for the fall conference. They are still working thru the Covid waiver list of trials. Public Health Administrator Christa Poggemiller reported her office is busy and they continue to provide vaccine drive-thru clinics at SCC on Monday, Wednesday, and Friday's from 8:30am to 4pm. until November 19th. Then they will move back to the Health Department building for vaccines. On November 18th they will start administering the pediatric vaccine. The current 7-day COVID positivity rate is 9% with 72 cases. The County has an 82% vaccination rate for those 65 and older and a 58% vaccination rate for those 18 and older.

McCampbell motioned to open the 2nd public hearing for Amended Flood Plain Ordinance #25. Seconded by Cary. Assistant Land Use Administrator Jarred Lassiter discussed the reason for the additional amendment to the ordinance is to clarify the dates of the FIRM maps and other dates to include in the ordinance as required by FEMA. This is a minor text change. No public comments were received. McCampbell motioned to close the public hearing and seconded by Cary. McCampbell motioned to approve Amended Flood Plain Ordinance #25 and waive the 3rd hearing. Seconded by Cary.

AMENDMENT TO ORDINANCE #25

WHEREAS the Des Moines County Board of Supervisors adopted a revised version of the Des Moines County Floodplain Development Ordinance (Ordinance No. 25) on October 5, 2021, and

WHEREAS an error of omission was soon after discovered within the text of Ordinance No. 25, in which a portion of unincorporated Des Moines County was unintentionally excluded from the description of the jurisdiction covered by the Ordinance,

NOW THEREFORE, BE IT RESOLVED: That the Board of Supervisors hereby amends Ordinance No. 25, by altering the second sentence of Article II, Section A, so that it reads as follows:

“The Flood Insurance Rate Maps (FIRMs) for Des Moines County and Incorporated Areas, as listed on FIRM Index 19057CIND0C dated October 21, 2021, which were prepared as part of the Des Moines County Flood Insurance Study, shall be used to identify such flood hazard areas and all areas shown thereon to be within the boundaries of the base flood shall be considered as having significant flood hazards.”

Approved and adopted this 9th day of November, 2021.
