County Treasurer Janelle Nalley-Londquist reported her office will be sending out tax sale notifications this week. Her office is also busy preparing for the end of the fiscal year. MHASEI CDS Director Ken Hyndman also reported his office is preparing for the end of the fiscal year. Maintenance Director Rodney Bliesener reported his crew is working on moving Safety and Emergency Management to their new location at the old Conservation Office. He has a few agenda items. Safety Director Angela Vaughan reported she is busy. She would also like to thank Rodney and his staff for their assistance in moving the offices.
